To look after personal and public property. To expect consequences to follow misbehaviour.
PARENTS	 To receive a fair hearing of grievances. To be treated with respect, courtesy and civility. To be presented with clear, comprehensible assessments of student performance. To receive timely notification of problems both social and scholastic. To participate in all aspects of their student's education 	 To help students in their organisation. To respect their children. To be fair and consistent. To encourage and reinforce good results and behaviours. To apply consequences to misbehaviour. To be good role models. To help enforce the code of behaviour. To respect school staff. To be supportive of their school's ethos and goals.
